#### ORDINANCE NO. 2015-01

#### AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 2—Streets And Rights Of Way, Subchapter 4—Parking)

BE IT ORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

# § 1. Amending Village Code

Chapter 2 of the Village Code entitled *Streets And Rights Of Way*, is amended by adding the following as Subchapter 4 entitled *Parking*:

# Subchapter 4—Parking

# § 235. Parking in cul-de-sacs

No person shall park a vehicle or permit the same to be parked or left standing in any "T" shaped cul-de-sac.

# § 236. Parking on village streets during snow event

No person shall park a vehicle or permit the same to be parked or left standing on any village street during or within 12 hours after a snow event defined as a snowfall of 1" or more.

### § 237. Citation

The code enforcement officer of the village or any Kane County Sheriff's deputy has the authority to issue citations for any violations of this subchapter. When an authorized officer, based upon personal observation or investigation, has reasonable cause to believe that a person has committed a violation of this subchapter, the officer is authorized to issue a

citation by (a) personal service upon the violator, or (b) posting a copy of the citation in a conspicuous place on the vehicle and causing a copy of the citation to be mailed by regular, first class mail, postage prepaid, addressed to the owner of record of the vehicle. An officer may, in lieu of issuing a citation, give notice of the violation which shall serve as notice to the violator to remedy the violation within the time specified. If the violator fails or refuses to remedy the violation within the time specified, the officer is authorized to issue a citation. Citations issued under this subchapter shall be heard by the Code Hearing Department in accordance with § 185.

# § 2. Repealer

Any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, hereby repealed.

## § 3. Effective Date

This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
