AN ORDINANCE GRANTING A VARIATION FROM THE ZONING ORDINANCE

(6N095 Sunset Views Drive, St. Charles, IL 60175)

A public hearing on the application of the Ryan and Darcy Scheuer for a variation under the Zoning Ordinance from the area limitations applicable to accessory buildings and structures in the R1 Residence District for the property at 6N095 Sunset Views Drive, St. Charles, IL 60175, was held before a duly appointed hearing officer of the Village on October 9, 2023, upon due notice published according to law.

After hearing from the Applicant and all members of the public present at the hearing, and after considering all written materials submitted in support of or against the application, the hearing officer recommended that the application be granted.

NOW THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, as follows:

§ 1. Variation granted

- (a) A variation of 395 square feet is granted from the area limitations applicable to accessory buildings and structures in the R1 Residence District for the property at 6N095 Sunset Views Drive, St. Charles, IL 60175 for the construction of a basketball court. (Actual size = 1300 square feet; size limitation = 908 square feet.) The property is legally described on Exhibit A Attached.
- (b) This variation is subject to the applicant filing a copy of the approval of the basketball court by the Homeowners Association with the Clerk within 30 days of the date of this ordinance. If the Homeowners Association requires that the basketball court be screened,

this variation is subject to the applicant installing the required screening within six months from the date of this ordinance .

§ 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, repealed.

§ 3. Effective Date

This ordinance is fully effective from and after its passage, approval and publication as provided by law.
