## Golf Cart Vehicle Self-Certification Checklist

### 1. Vehicle Requirements – all items must be checked and in good working order

- **1.1. Brakes**
  - Functioning brakes are installed and operational.
- **1.2. Steering Apparatus**
  - Steering apparatus is functional and allows for safe vehicle operation.
- **1.3. Tires**
  - Tires are in good condition, with adequate tread and no visible damage.
- **1.4. Rearview Mirror**
  - Rearview mirror is installed and provides a clear view of the road behind.
- **1.5. Slow-Moving Emblem**
  - State-approved slow-moving emblem is affixed to the rear of the vehicle.
- **1.6. Lighting**
  - Headlights emit a white light visible from at least 500 feet in the dark.
  - Brake and tail lamps emit a red light visible from at least 100 feet in the dark.
  - Headlights and tail lamps are *lighted at all times during operation on a roadway*.
- **1.7. Horn**
  - Horn is operational and audible from at least 250 feet.
- **1.8. Turn Signals or Hand Signals**
  - Turn signals are functional OR
  - Hand signals are used to indicate turns.

## 2. Operational Requirements

- **2.1. Mandatory Insurance**

- Operator complies with Article VI of Chapter 7 of the Illinois Vehicle Code, including the requirement for mandatory insurance and supplies a copy of the insurance with this registration. Operator complies with the user's manual of the registered vehicle.

- **2.2. Age Requirement**

- Operator is 13 years of age or older.

- **2.3. Traffic Laws**

- Operator complies with all applicable traffic laws.

- **2.4. Occupant Limitation**

- Number of occupants does not exceed the number of available seats.

- **2.5. Speed Limit**

- Vehicle is operated only on streets with a posted speed limit of 35 mph or less.

- **2.6. Prohibited Areas**

- Vehicle is not operated on toll roads, interstate highways, or controlled access highways. (Rt 64; Rt 47)
- If crossing a municipal street, the operator makes a direct crossing as required by law.

## 3. Permit and Waiver

- **3.1. Permit Acquisition**

- Permit obtained from the Village Clerk.

- **3.2. Waiver of Liability**

- Waiver signed, acknowledging the Village's non-liability for the operation of the golf cart within the village.

**Waiver of Certain Claims: Indemnity by operator.**

**Operator on behalf of Operator and Operator's minor children, if any, acknowledges that Operator is not an intended user of the Village's streets but is merely a permitted user. To the extent not expressly prohibited by law, Operator on behalf of Operator and Operator's minor children, if any, releases the Village, its officers, agents, servants and employees, from and waives all claims for damages to persons or property sustained by Operator or Operator's minor children, or by any other person, resulting directly or indirectly from the operation of the licensed golf cart by Operator or Operator's minor children and from any casualty, cause or any existing or future condition, defect, matter or thing in or about the golf cart, or from any equipment or appurtenance attached thereto, or from any accident involving the golf cart.**

**Indemnification. To the extent not expressly prohibited by law, Operator shall hold the Village, its officers, agents, servants and employees, harmless and shall indemnify each of them against all claims and liabilities, including reasonable attorney's fees, for injuries to all persons and damage to property occurring or arising from the operation of the golf cart by Operator or Operator's minor children.**

**Operator's obligation to indemnify the Village includes the duty to defend against any claims asserted by reason of any such claims or liabilities and to pay any judgments, settlements, costs, fees and expenses, including attorney's fees, incurred in connection therewith.**
