ORDINANCE NO. 2024-07
AN ORDINANCE AMENDING VILLAGE CODE
(Chapter 7—Public Safety, Subchapter 4—Nuisances)

BE IT ORDAINED by the President and the Board of Trustees of the Village of LILY LAKE, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Amending Village Code

Chapter 7—Public Safety, Subchapter 4—Nuisances, § 766 is amended to read as follows:

§ 766. Noise

(a) Making or permitting noise that exceeds 55 dBA when measured from the closest outside wall of any residence within 100 feet or more of the source, between the hours of 10:00 PM and 7:00 AM on Sunday through Thursday and legal holidays and between the hours of 11:00 PM and 7:00 AM on Fridays and Saturdays is prohibited.

(b) Nothing in this section is intended nor should it be construed as preventing the lawful exercise of the right of free speech protected by the constitutions of the United States or the State of Illinois.

(c) This section does not apply to—

- (1) noise generated by agricultural equipment on land zoned A–Agriculture and actually used for agricultural purposes,
- (2) noise generated by emergency equipment or vehicles in the course of responding to an emergency, and
- (3) work performed for or on behalf of a public body.

(d) A complainant alleging a violation of this section must make a formal complaint to the Kane County Sheriff's Office. Any citation issued will be processed by the Kane County Administrative Adjudication Officer through the county's Administrative Code Hearing Department.

§ 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of the conflict, repealed.

§ 767. Effective Date

This ordinance is effective when it is passed, approved and published as provided by law.


