Adoption of the Agenda

Motion by Trustee Conn, seconded by Trustee Dell, to adopt the February 28, 2022 Agenda as presented. *Voice vote, motion passed unanimously.*

Approval of the January 24, 2022 Regular Board Meeting Minutes

Ordinance 2022-01 Amend Village Code – Fees – Stormwater Management

Old Business

Trustee Conn asked for an update regarding the tree clearing at the gas station location on Rt 64. President Overstreet informed her that the tree clearing did not require a permit, but the vast amount of land clearing violated the stormwater management ordinance as there was no permit applied for. A citation hearing has been set to address the violation.

New Business

Clerk Heffernan updated the Board regarding the new "School Zone" signs on Rt 47 at the Lily Lake Grade School. It was noted that the Village received no notification of the signs being installed and the location of these signs may need to be reviewed; they are confusing.
