Village of Lily Lake, Kane County, Illinois 2024 Petition Guidelines for 2025 Consolidated Election; April 1, 2025

The Village of Lily Lake will be accepting nomination papers from candidates for municipal office beginning November 12, 2024 through November 18, 2024. The Village is located at 43W955 Twilight Lane, St. Charles, IL 60175.

Petition filing hours will be during regularly posted office hours with extended office hours on Monday, November 18, 2024.

Regular Hours: M-TH, 9:00 am - 1:00 pm

November 18, 2024 hours: 9:00 am - 1:00 pm (closed 1:00-4:00) 4:00 pm - 5:00 pm

Lily Lake is a non-partisan municipality.

Submitted election packets should contain a non-partisan Statement of Candidacy, a non-partisan Petition signature page (non-municipal and commission form of municipality), Statement of Economic Interest receipt, and a Loyalty Oath. Signature requirements are on document page 33 of the above-mentioned Candidate's Guide. (Non-partisan Village).

Village Clerk will not notarize filings for village positions to avoid an appearance of impropriety.

All documentation must be filled out correctly – consult the State of Illinois 2025 Candidate's Guide, the State Elections Board (see below for contact info) or legal counsel.

Ballot position is determined as follows:

1. All petitions filed by persons waiting in line the first day of filing before the office opens will be deemed filed simultaneously.
2. Petitions filed by mail and received at opening in the office of the first day of filing will be deemed filed simultaneously.
3. Ballot position for subsequent filings is determined by time and date.
4. A lottery drawing approved by the State Board of Elections will be held for simultaneous filings to break any ties.
5. Persons seeking assistance with filing of documents at the open of business on the first day of filing will NOT be considered to have filed at opening time for the purpose of a lottery draw for ballot position.
