AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 1—Administration, Subchapter 2—Officers)

BE IT ORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Amending Village Code

Chapter 1—Administration, Subchapter 2—Officers, § 115 is amended by adding the following as subsection (e):

(e) Pursuant to the § 11-1-6 of the Illinois Municipal Code (65 ILCS 5/11-1-6) and § 3305/11 of the Illinois Emergency Management Agency Act (20 ILCS 3305/11), the president may declare a local disaster within the village when, as a result of the occurrence or threat of widespread or severe damage, injury or loss of life or property resulting from any natural, technological, or human cause, including but not limited to fire, flood, earthquake, windstorm, hazardous materials spill or other water contamination requiring emergency action to avert danger or damage, epidemic, air contamination, blight, extended periods of severe and inclement weather, drought, infestation, critical shortages of essential fuels and energy, explosion, riot, hostile military or paramilitary action or other public health emergency, cyber incidents or acts of domestic terrorism, the president deems it necessary to activate the emergency operations plan of the village and to authorize the furnishing of aid and assistance thereunder. The declaration shall be substantially in the form set forth below and may not be continued or renewed for more than seven days except with the consent of the corporate authorities of the village. Any proclamation declaring, continuing, or terminating a local disaster declaration will be given general publicity and filed promptly with the clerk.

Declaration of Local State of Emergency

Pursuant to the authority vested in the office of Village President by the Illinois Municipal Code Section 5/11-1-6, the Illinois Emergency Management Agency Act, Section 3305/11 and the Lily Lake Village Code, I, _____, the Village President of Village of Lily Lake, Kane County, Illinois (the "Village") do hereby declare that a Local State of Emergency exists as of this date, _____, 20____, and shall continue until such time as provided below.

It is the policy of the Village to be prepared to address any disasters and, therefore, it is necessary and appropriate to make additional Village resources available to ensure that the effects of _____ are mitigated and minimized and that residents and visitors in the Village remain safe and secure.

This proclamation will activate the Village's emergency operations plan by proclaiming that a disaster exists within the Village. This proclamation of disaster will assist the residents of Lily Lake, by and through its Emergency Management Agency and to coordinate federal, state, county and municipal resources and response activities, in an effort to prevent and reduce further damage and hazards, protect the health and safety of persons, protect property and provide emergency response.

Therefore, I, _____, by virtue of the authority vested in me as Village President of the Village of Lily Lake, Kane County, Illinois, and pursuant to the Illinois Emergency Management Agency Act, 20 ILCS 3305/11, the Illinois Municipal Code 65 ILCS 5/11-1-6, and the Lily Lake Village Code, proclaim that a disaster exists within the Village of Lily Lake, Illinois, and hereby proclaim the existence of a Local State of Emergency.

During the existence of the Local State of Emergency, the Village President shall execute such authority as provided under the Illinois Municipal Code, the Illinois Emergency Management Agency Act and the Lily Lake Village Code.

This Declaration of Local State of Emergency shall be filed with the Village Clerk as soon as practicable.

This proclamation is effective on this ____ day of _____, _____ and shall continue for a period not to exceed 7 days, unless extended by the Village Board.


