## ORDINANCE NO. 2024-02

AN ORDINANCE EXTENDING AN INTERGOVERNMENTAL  
AGREEMENT REGARDING JURISDICTIONAL BOUNDARIES WITH  
THE VILLAGE OF BURLINGTON

BE IT ORDAINED by the President and the Board of Trustees of the Village of LILY LAKE, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Recitals

(a) On March 21, 2005, the Village of Lily Lake in the Village of Burlington entered into an intergovernmental agreement pursuant to the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*) establishing a jurisdictional boundary between the two municipalities for the purpose of planning and zoning jurisdiction.

(b) Pursuant to the Illinois Municipal Code the agreement is effective for a term of 20 years.

(c) Lily Lake and Burlington now wish to extend the agreement for an additional term of 20 years and to that end have approved the form of an Extension Agreement, a copy of which is on file in the clerk's office.

§ 2. Approval of Extension Agreement

(a) The recitals set forth in the previous section are true and correct and are incorporated into this ordinance as if fully set forth.

(b) The Extension Agreement between the Village of Lily Lake and the Village of Burlington, a copy of which is on file in the clerk's office, is approved and the president and clerk are authorized and directed to sign the agreement and deliver a certified copy thereof to the Village of Burlington in exchange for a certified copy of the Extension Agreement executed by the Village of Burlington.

§ 3. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of the conflict, repealed.

§ 4. Effective Date


This ordinance is effective when it is passed, approved and published as provided by law.


